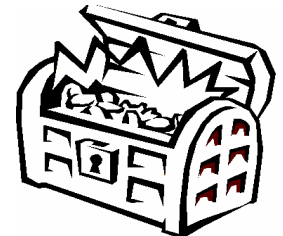
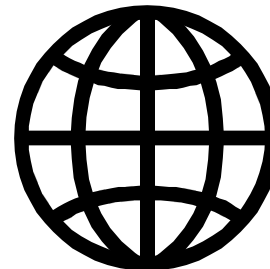

### Application Form for Membership

2. The premium will be £30, paid by cheque or standing order for ten monthly payments of £3.
3. There will be four draws a year which will take place at the Summer Lunch in July 2011, the Executive Meetings in September 2011 and in February 2012, and at the Annual General Meeting in March 2012 under the supervision of the Officers of the Society
5. Individuals may form syndicates or take out multiple premiums, as may Branches and Groups. However, one named person must be responsible for each syndicate.
6. Application forms with cheques should be received up to the 1st July 2011; application forms with standing orders should be received no later than 28th May 2011.
7. On receipt of a completed application form, together with a cheque or completed standing order mandate, members will be issued with a number for each premium they have paid.
